

ORDINANCE 46 - 2003

**ORDINANCE OF THE BOROUGH OF MADISON REPLACING ORDINANCE 5-2002
PERTAINING TO PART-TIME NON-UNION SALARIES AND OFFICES**

WHEREAS, certain changes are required in the salary ranges for non-union part-time employees;

NOW, THEREFORE, BE IT ORDAINED, by the Council of the Borough of Madison, County of Morris, State of New Jersey, as follows:

Section 1. Ordinance 5-2002 is hereby replaced by this ordinance in order to identify all non-union part-time positions and to change salary ranges for non-union, part-time employees, as follows:
