

ORDINANCE 40 – 2003

ORDINANCE OF THE BOROUGH OF MADISON FIXING SALARIES AND WAGES FOR POSITIONS REPRESENTED BY THE BOROUGH OF MADISON EMPLOYEES FEDERATION - SUPERVISORS

WHEREAS, the positions of Court Administrator, Senior Citizen Coordinator, Tax Collector, Director Project Pride, Recreation Director/Recycling Coordinator, Construction Code Official, Engineering Assistant/Construction Observer (through December 31, 2003) and Utility Collector (beginning January 1, 2004) are represented for the purpose of collective bargaining by the Borough of Madison Employees Federation - Supervisors (hereinafter "Federation - Supervisors");

WHEREAS, the Borough and the Federation-Supervisors reached agreement on wages and salaries for a new collective bargaining agreement which shall be effective January 1, 2003 through December 31, 2005;

NOW, THEREFORE, BE IT ORDAINED by the Council of the Borough of Madison, County of Morris, State of New Jersey, as follows:

Section 1. The attached wage schedule for job classifications setting salary ranges for Federation–Supervisors is hereby established for the years 2003, 2004 and 2005.

Section 2. This Ordinance shall take effect as provided by law.
