TAKE NOTICE that on the 13th day of April, 2023, at 7:30 pm a public hearing will be conducted by the Zoning Board of Adjustment of the Borough of Madison on the application of the undersigned for approval to permit: a one story addition on the rear of the house on the premises located at 7 Academy Road and designated as Block 3001 Lot 53 on the Borough of Madison Tax Map.

The variances and other approvals requested by the applicants are as follows:
