TAKE NOTICE that on July 9, 2020 at 7:30 pm a public hearing will be conducted by the Zoning Board of Adjustment of the Borough of Madison, on the application of the undersigned for approval to permit:

Construction of 1 Story Addition and Storm Water Management System on the premises located at 3 Nordling Lane and designated as Block 3301, Lot 19 on the Borough of Madison Tax Map.

The variances and other approvals (if any) requested by the applicant are as follows:
Code Section 195-29.3 Minimum Side Yard Setback where 22.2 feet is permitted, 25.2 feet is existing and 12.0 feet is proposed. Code Section 195-29.3 Maximum Impervious Lot Coverage where 20.0% is permitted, 21.77% is existing and 23.53% is proposed. The Applicant may also seek other variances and waivers as the need may arise during the course of the hearing on this Application.
